Location: Muhlenberg College, John Dietrich Fieldhouse, 2300 Liberty St, Allentown, PA 18103 (see reverse)

Format: High School (8th grade – 12th grade). 16 Teams. Pool wrestling, 5 matches guaranteed.

Entry: \$400 per team. A \$40 fee per person is due if you are not on a team roster and want to be a free agent. The entry fee includes: 19 Wrestlers (14 Starters and 5 Reserves), 2 Coaches & 1 Table workers pass. Balance must be paid either online or in-person before weighing in.

Seating: Limited chair seating will be available. It is recommended that you bring your own "field" chairs.

Weights: 106, 113, 120, 126, 132, 138, 145, 152, 160, 170, 182, 195, 220, 285

Rules: NFHS High School Rules

Exhibitions: Exhibitions between rounds are encouraged. Every round must start on time. Bouts are not allowed 5 minutes prior to start of next round.

Admission: \$8 Adults, \$5 Students, and children under 5 free.

Weigh-Ins: 7pm-9pm Friday June 1st, or 7am-8am Saturday June 2nd at Muhlenberg College This is a dual-meet event; therefore, everyone shows up and weighs in as a team. We will not weigh in wrestlers early. Any balance must be paid before weighing in. Your roster must be present at weigh in. Teams who cannot make Friday's weigh in, can weigh in Saturday Morning. No allowances.

Pools: In the competitive interest of the tournament or due to the number of entries, the tournament director reserves the right to establish pools, move teams or combine divisions.

Concessions: A full menu of hot and cold concessions will be available throughout the day, starting at 8:00am.

Waiver and Release
