- College out of bounds rules apply. \*\*\* Girls Divisions, see notes below \*\*\* Double Elimination Round robin will be created based upon registered. Any wrestler weighing more than 2.0 pounds over their registered weight will be disqualified with no refund.

**MORNING SESSION - START TIME: 9:00 AM- TOTS (AGE 6/UNDER), BANTAMS & BANTAM NOVICE (AGE 7/8), MIDGETS & MIDGET NOVICE (AGE 9/10), GIRLS DIVISION (K—12TH GRADE)**

**AFTERNOON SESSION - START TIME: 12 PM- JUNIORS & JUNIOR NOVICE (AGE 11/12), INTERMEDIATES (AGE 13/14), HIGH SCHOOL / OPEN DIVISION (POST HS /SENIOR CITIZEN)**

- **TROPHY to the Winner in all Brackets.** Medals to 2nd & 3rd Places. (Including Novice Bracket)
- **MVP Awarded** to the outstanding wrestler in each session (Excluding Novice and Open Brackets)
- Novice is defined as a wrestler who has 2 years of experience or less. 2018 wrestling season should be either their 1st or 2nd season wrestling. If you wrestle in a Novice Bracket as a 3 + year wrestler, you will be disqualified and forfeit your tournament fees.
- Concessions available. Vendors on site.
- Headgear mandatory. Only two coaches will be allowed on the mats during matches.
- Wrestlers may enter more than one AGE GROUP (but only one weight class) with extra registration fee. \*\*\*For Girls Division, ages 4 through 18, we will do our best to keep brackets within 3-4 years of age. (If there are not enough girls, there will be an option to wrestle in boy's bracket or receive a refund)
